

MINUTES of a Committee Meeting held on 8th February 2007 at Kingswood.

1. MEMBERS PRESENT  
Ms M Fitzgerald, Mrs J Davey, Mr T Rycraft, Mrs S Watson, Mrs I Benton, Mr C England & Mr T Coles.
2. APOLOGIES  
Apologies for absence were received from Mr B Smith, Mr D Carpenter & Mr M Wiedeholz.
3. MINUTES OF LAST MEETING  
It was proposed that the Minutes of the last Meeting held on 7<sup>th</sup> December 2006 be accepted. Agreed unanimously.
4. MATTERS ARISING
  - (a) **YOUTH TEAM:** Mr Coles informed the Committee that the uniform for the juniors had arrived and had been passed to the county team manager for issue.  
  
Before the county sponsored shirts are given to the players, it was confirmed that parents or guardians would have to sign an agreement form accepting their liability for the uniform. This will only be applied should they fail to return them or damage them; this liability was confirmed as £10 per shirt. Mr England will liaise with Mr Wiedeholz to sort out the paperwork.
  - (b) **COMPETITION SECRETARY'S REPORT:** Mrs Watson opened her report by saying that all competitions are going well; she confirmed that the National fours will be played at Hawkinge and they will invoice KCSMBA for the use of the hall.  
  
She reported that 32 teams had entered the Club Championships.

The Bowls & Brains day went very well. The winners were Dave Kruse, Steve & Brenda Francis. The Treasurer proposed to have another similar event on Saturday 29<sup>th</sup> December 2007.
  - (b) **AGM:** The Secretary informed the meeting that Mick Sayer from Langley SMBC has kindly booked Langley Village Hall for the next AGM and Langley bowls club are sponsoring the county by paying for the hall; **the next AGM will be on Sunday 10<sup>th</sup> June 2007.**
  - (c) **GENERAL:** Mr Rycraft informed the Committee that two members had shown their interest in putting forward a quote for the construction of a frame to store the county mats at Strood; the Secretary will follow this up.

Mr Coles stated that he had recently met a representative from Sport England, Mr Richard Boorman; he works toward youth development in all the variations of bowls, this could potentially be of great interest to our association therefore the Committee agreed to contact him to discuss this further.

The Treasurer read a letter from Mr Ray Anns requesting the use of the county's mats for the Swale bowls league; Committee agreed in principle, Secretary to ring Mr Anns to confirm the details.

The Treasurer continued by saying that a Kent select team will be playing a Norfolk over 60's team on the 24<sup>th</sup> March 2007; anybody interested in becoming one of the select team please contact Mr Derek Carpenter on 01634 865766.
